Key Responsibilities:

Network monitoring & incident management

- Oversee real-time dashboards, alarms and root-cause analysis for hardware, software and grid connectivity issues
- Coordinate 24/7 service procedures with internal teams and service partners

Service level performance

- Define, track and report on KPIs (uptime, call-to-resolution, customer satisfaction)
- Implement SLA enforcement and continuous improvement plans with O&M vendors

Preventive & corrective maintenance

- Develop maintenance schedules, spare-parts strategies and field-service workflows
- Approve and monitor service orders, ensuring HSSE and quality standards

Vendor & contract management
